We will only specify the theme for the cover story. Other articles may or may not match the cover-story theme. All other articles will be assessed by the Journal Committee as to their suitability for publication. The cover-story themes and editorial submission deadlines for the future issues are:

### **INFORMATION AND REQUIREMENTS FOR AUTHORS**

The *Canadian Welding Association Journal* is written for and distributed to leading welding professionals across Canada. The Journal accepts suitable articles for publication. Authors are not paid for their material; however, the Journal's reach to a wide readership of leading industry professionals and its long life on the CWA website ([www.cwa-acs.org](http://www.cwa-acs.org)) provide author recognition. Articles should be between 700 and 1,500 words in length. Longer articles will be considered. Articles and papers that exceed this length may be published in summary in the Journal and in full on the website. Supporting graphics and pictures where appropriate are encouraged. Authors should indicate the issue for which the article is submitted. Articles will be presented to CWA's Journal Committee for review and consideration for publication. The Journal Committee will also consider proposals for articles.

The article must be accompanied by the following:

- Author's name, title and company (if applicable), address, phone number and email address.
- Notification of previous publication of the article.

**• Graphics and pictures in high-resolution image files separate from the file containing the**

**text (eps format preferred, jpeg format very acceptable - minimum resolution 300 dpi).**

**• Please use filenames that identify you, the article, the content and the graphics.**

**(i.e. smith\_tig\_welding.doc, smith\_figure\_1.jpg NOT cwa\_welding\_article.doc)**
